Long-Term

Disaster Recovery & New Build

When homes in **Central Appalachia** are devastated by flash floods, wildfires or other natural disasters, friends like you allow ASP to make long-term commitments to serve families in need. From home repairs to brand new construction, you assist in rebuilding entire communities, one family at a time. And through ASP's New Build Tennessee program, families whose homes are beyond reasonable repair are provided with the gift of a new home. ASP homes are gifts of grace, a fresh start to those in need. We pair grant funds with gifts from private sources to cover the cost of new homes.



ASP has committed to long-term flood recovery efforts in Rainelle, West Virginia. **Fifty-five** families have already received brand new homes. Another **50 homes** are planned.



ASP has committed to building **25 new homes** as part of our long-term fire recovery efforts in Sevier County, Tennessee. The majority of the devastation occurred in the Gatlinburg area, with some damage in Pigeon Forge and Sevierville as well.



ASP has committed to building **new homes** in Tennessee for residents living in substandard housing conditions.

-  **6 homes** completed in 2017

-  **8 homes** completed in 2017
-  **10 new homes** expected to be built in 2018

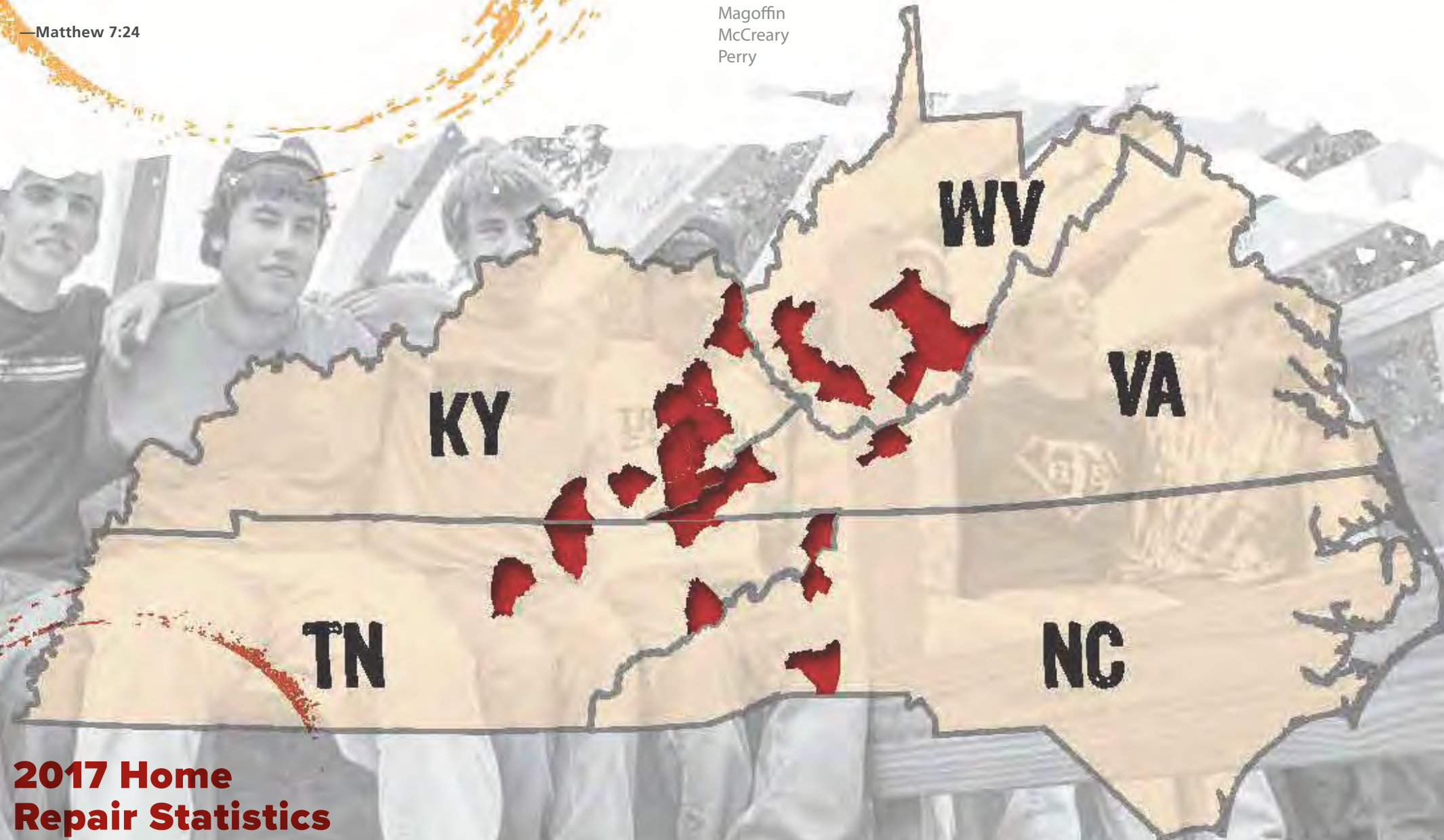
